PRIVACY POLICY

- 1.2.3 "Personal Information" means information relating to an identifiable, living, natural person and where it is applicable, identifiable, existing juristic person, including but not limited to:
- 1.2.3.1 information relating to the race, gender, sex, pregnancy, marital status, national, ethnic or social origin, colour, sexual orientation, age, physical or mental health, well-being, disability, religion, conscience, belief, culture, language and birth of the person;
- 1.2.3.2 information relating to the education or the medical, financial, criminal or employment history of the person;
- 1.2.3.3 any identifying number, symbol, e-mail address, physical address, telephone number, location information, online identifier or other particular assignment to the person;
- 1.2.3.4 the biometric information of the person;
- 1.2.3.5 the personal opinions, views or preferences of the person;
- 1.2.3.6 correspondence sent by the person that is implicitly or explicitly of a private or confidential nature or further correspondence that would reveal the contents of the original correspondence;
- 1.2.3.7 the views or opinions of another individual or person; and/or
- 1.2.3.8 the name of the person if appears with other personal information relating to the person or if the disclosure of the name itself would reveal information about the person;
- 1.2.4 shall have the meaning contemplated in clause 5;
- 1.2.5 means any operation or activity or any set of operations, whether or not by automatic means, concerning personal information, including
- 1.2.5.1 the collection, receipt, recording, organisation, collation, storage, updating, modification, retrieval, alteration, consultation or use;
- 1.2.5.2 dissemination by means of transmission, distribution, or making available in any other form; and/or

- 1.2.5.3 merging, linking, as well as restricting, degradation, erasure or destruction of information, and "**Processed**" and "**Process**" shall have a corresponding meaning;
- 1.2.6 "POPI" means Protection of Personal Information Act No. 4 of 2013 and includes the regulations published under that Act, and any amendments to that Act and/or the regulations from time to time (if any);
- 1.2.7 "RSA" means the Republic of South Africa;
- 1.2.8 "Services" means all the services offered by Store it All at the Airport CC as well as on our Website;
- 1.2.9 "Terms and Conditions" means the terms and conditions displayed on this Website; and
- 1.2.10 "Website" means www.storeitall.com

PROCESSING OF YOUR PERSONAL INFORMATION

2.1 What personal Information do we Process:

2.1.1 Personal information provided by customers and companies

2.2 What Non-Personal Information do we Process:

- 2.2.1 As permitted by ECTA, Store it All at the Airport CC may use Personal Information collected to compile profiles for statistical purposes. No Personal Information contained in the profiles or statistics will be able to be linked to any specific user.
- 2.2.2 To this end, we anonymise and aggregate your Personal Information. We may share this non-Personal Information with our trusted partners to facilitate their property-related endeavours, which may prove to benefit you, by promoting your property preferences.

2.3 Automatic Processing of information:

- 2.5.3.1 you to directly submit your Personal Information to Store it All at the Airport CC, as contemplated in 2.4.1 above; and

2.5.3.2 Store it All at the Airport CC to obtain your indirect Personal Information in respect of the Candidate from the sources in clause 2.4.2 above, and you hereby unconditionally and irrevocably consent to the collection of your Personal Information in the manner contemplated in clause 2.4.3 above, and to its subsequent Processing.

2.6 Where we store your Personal Information:

The Personal Information which we collect from you may be disseminated to, and stored at a destination outside the RSA.

2.7 To whom do we disseminate your Personal Information:

- 2.7.1 Store it All at the Airport CC may disseminate your Personal Information to any member in our "group of companies" as that term is defined in the Companies Act.
- 2.7.2 For the avoidance of doubt, the above, includes but is not limited to the following persons who may be located outside the borders of RSA, namely, our employees, related bodies, contractors, franchisees, franchisees' employees or service providers for the purpose of operation of our business, fulfilling requests by you, and to otherwise provide our Services to you;
- 2.7.3 In addition to the above, Store it All at the Airport CC may disseminate your personal Information to third parties (inside and/or outside the RSA) with whom we have commercial relationships, for business, marketing and related purposes
- 2.7.4 Notwithstanding the above, Store it All at the Airport CC shall disseminate your Personal Information to the relevant third parties concerned should one of the following occasions transpire, if:
- 2.7.4.1 Store it All at the Airport CC is legally obliged in terms of statue to disseminate your Personal Information;

- 2.7.6 You hereby acknowledge that if you send us a request (for example via a support email or via our feedback mechanisms) we reserve the right to publish it on our Website, which shall enable us to convey our response and/or clarify an issue to you, clients and potential clients.

2.8 What happens if you refuse to provide us with your Personal Information:

- 2.8.1 If you do not provide us with the Personal Information that we request, some or all of the following may happen:
- 2.8.1.1 we may not be able to provide our Services to you, at the standard at which we usually deliver, or at all; and
